NOTICE OF PUBLIC TUITION HEARING

THIS IS A VIRTUAL HEARING

The Arizona Board of Regents will conduct a virtual public hearing for testimony and comments from the public, students, and other interested parties regarding the following:

1. The tuition and academic fees to be charged for resident and nonresident students at Arizona State University, Northern Arizona University and the University of Arizona for Academic year 2023-2024, and
2. The growth rates of tuition and academic fees for students at Arizona State University, Northern Arizona University and the University of Arizona for academic years 2024-2025 through 2028-2029.

This notice is provided pursuant to A.R.S. § 15-1626.

To participate in the virtual public hearing and **comment on the proposals**:

- Register to speak at the virtual public hearing by submitting an online form [available here](#) or https://asu.zoom.us/webinar/register/WN_wxC2sU6RjSpeiDYeaqjCw
- The form may be submitted **before or during** the public hearing. A confirmation email will be sent with hearing connection information.
- Participants who join the hearing as instructed in the confirmation email will initially be placed in a virtual waiting room until the hearing begins, at which point participants will be able to hear and see the hearing in progress until called to speak. Please be patient while in the waiting room - the hearing will not begin until all participants are out of the waiting room.
- During the public hearing, speakers will be called in the order online forms are submitted.
- If a speaker is not available when their name is called during the public hearing, the next speaker in line will be called. (If time allows at the end of the meeting, missed speakers may be allowed to comment.)

- Individuals who are commenting during the public hearing will be enabled to activate their audio and video when their name is called. (The speaker's video may go dark for a few seconds as permission for sound and video is granted.)
- Comments are limited to two minutes per speaker to permit as many speakers as possible to comment.
- Regents generally do not respond to questions during the hearing to allow for the maximum number of speakers to voice comments on the tuition proposals.
- If there are not enough speakers signed up to fill the entire two hours, the hearing may end earlier than scheduled.
- Rules of conduct for this virtual public hearing are the same as those for meetings in person.

- Comments submitted and made at the hearing become part of the public record.
